The meeting was chaired by the Jute Commissioner. On behalf of NJB, Dr. Mahadeb Datta, Head (Tech.) welcomed all the attendee members. Thereafter the agenda items were taken up for discussion. The list of attendees present virtually is enclosed at Annexure – A.

Agenda 1: Confirmation of the Minutes of the 6th Technical Committee under CSAPM held on 03.03.23

The minutes of the 6th Meeting of the Technical Committee under CSAPM held on 03.03.23, after being duly approved by the Chairman, were circulated to the members vide NJB's communication no. NJB/CSAPM/6th TC-Minutes/2022-23/8852-58 dated 09.03.2023.

Since, no further correspondence received in this regard, the minutes have been considered as approved by the Committee.

Agenda 2: Action Taken Report on 6th Technical Committee (TC) meeting

- The Committee noted the actions taken as per direction of the 6th TC meeting.
- Further, the status of *de-novo* registration of M/s Monarck Engineers and M/s ALS Industries was discussed in length. Sh. R. Chandran, Dy. Director, Textiles Committee reported that both the vendors have re-approached with revised audited balance sheets. The Committee advised Textiles Committee to assess the documents and update the status of *de-novo* registration accordingly at the earliest.

The Chairman reiterated the actual motto of *de-novo* registration alongwith the objectives of the Scheme and advised Textiles Committee to take necessary action accordingly.

- The reasons for disqualification of some vendors were also discussed in length. After due deliberation, the Chairman requested the Textiles Committee to further streamline the process of *de-novo* registration to the extent practicable; however within the extant provisions of the scheme guidelines.
- Regarding the status of the *de-novo* registration and interim price list forwarded by the Textiles Committee were placed before the Committee. The Committee suggested that the status of *de-novo* registration and price-list may be updated by the Textiles Committee after obtaining necessary inputs from the concern vendors and re-submit it to NJB at the earliest for placing it before the next TC meeting.

The Chairman concurred with the proposal and advised Textiles Committee to expedite the process.

The Committee noted the representation. The Chairman advised Industry Associations especially JPDEPC to take up the matters related to the submission of claim proactively.
