The meeting was held under the Chairmanship of the Jute Commissioner. On behalf of NJB, Dr. Mahadeb Datta, Head (Tech.) welcomed all the attendee members. Thereafter the agendas were taken up for discussion. The list of attendees present physically and virtually is enclosed at Annexure – I.

**Agenda 1: Confirmation of the Minutes of the 7<sup>th</sup> Technical Committee (TC) under CSAPM held on 19.06.23**

The minutes of the 7<sup>th</sup> Meeting of the TC under CSAPM held on 19.06.2023, after being duly approved by the Chairman, were circulated to the members vide NJB's communication no. NJB/CSAPM/7<sup>th</sup> TC-Minutes/2023-24/9466-72 dated 10.07.2023.

Since, no further correspondence received in this regard, the minutes have been considered as approved by the Committee.

**Agenda 2: Action Taken Report on 7<sup>th</sup> Technical Committee (TC) meeting**

The Committee noted the actions taken as per direction of the 7<sup>th</sup> TC meeting.

**Agenda 3: Matter related to De-novo Registration under CSAPM**

- On perusal of the status of De-novo registration, Chairman opined that the vendors who have not submitted required documents or withdrawn applications, a reminder may be issued again by the Textiles Committee and intimate to NJB the reasons for such actions by the vendors.
- After due deliberation, the price-list of the machines mentioned from 1 to 74 are considered as approved by the Committee. The Chairman approved the proposal for publishing it in the NJB's website [www.jute.com](http://www.jute.com)
- Issue related to the foreign vendor enlistment: The matter of M/s Juki, Singapore discussed at length and the Committee proposed that the vendors (indigenous & foreign) having A-TUFS registration shall be suo-moto considered as enlisted vendor under CSAPM by NJB. Further submission of applications and fees to the Textiles Committee may not be required for A-TUFS (implemented by the O/o TxC, MoT) registered vendors. However, NJB will seek the pricelist from those vendors for preparation of the price list time to time.

The Chairman agreed with the proposal for the ease of doing business.

In case of Juki, Singapore, the Committee advised that the maximum basic eligible price of the machines would be considered by the Textiles Committee during preparation of



TAR based on the price list of the similar machines supplied by M/s Juki India Pvt. Ltd. and M/s IIGM Pvt. Ltd. or purchased Price by JDP unit whichever is minimum since the said all vendors are authorized agent of Juki Brand.

- **Issue of M/s Suzhou T.U.E Hi-Tech Non-woven Machinery Co. Ltd.:** The matter of M/s Suzhou T.U.E Hi-Tech Non-woven Machinery Co. Ltd. was thoroughly discussed by the Committee. However, the proposal of the vendor was not accepted and recommended by the Committee. The Chairman concurred with the above opinion of the Committee.

**Agenda 4: Status of LOI, Claim etc.**

The Committee noted the status and the Chairman advised NJB to pursue with the rest of the applicants. Head /Technical has apprised the Committee that issuing reminders to the applicants are already inbuilt with the system and NJB also regularly in contact with the applicants for submission of their claims within the due date. The Chairman advised NJB to hold awareness campaign in Kerala, Panipat, Gazipur, Kolkata and in other places to sensitize the local JDP units for availing benefits under the scheme.

**Agenda 5: Incorporation a new module into the online system of CSAPM regarding submission of report on modernization**

After scrutinizing the format, the Committee suggested for certain modification. After that the same may be incorporated into online system.

The modified format is enclosed at Annexure-II.

**Agenda 6: Modification of CSAPM Scheme guidelines**

Subsequent to the review meeting on modification of scheme guidelines by MoT and after detailed discussions, the Committee recommended that for the vendor enlistment criteria investment on major machinery should not be less than Rs.25.00 Lakhs. The earlier recommendation of the Technical Committee (minimum investment of Rs. 1.00 crores which includes land and building other than machinery) stands superseded due to challenges in assessing land / building values. The Committee advised NJB to forward the recommendation to the Ministry along with the required minor modifications to make the Scheme more inclusive. The modified scheme guidelines has been attached at Annexure-III.

**Agenda 7: Any other issues with the permission of the Chair**

There being no other issues, the meeting ended with a vote of thanks to and from the Chair.
