The meeting was held under the Chairmanship of the Jute Commissioner. On behalf of NJB Dr. Mahadeb Datta, Jt. Director (TT) welcomed all the attendee members. Thereafter the agenda items were taken up for discussion. The list of attendees is enclosed at *Annexure – A*.

Agenda 1: Confirmation of the Minutes of the 1st Technical Committee under CSAPM held on 10th August'2021

The minutes of the 1st Meeting of the Technical Committee under CSAPM held on 10th August, 2021, after being duly approved by the Chairman, was circulated to the members vide NJB's communication no. NJB/CSAPM/2021-22/1stTC Minutes/4928-4933 dated 16th August'2021.

The minutes have been considered as approved.

Agenda 2: Action Taken Report on 1st Technical Committee meeting

The Committee noted the action taken by NJB as directed in the 1st TC meeting.

Agenda 3: Matter related to De-novo Registration under CSAPM

The Committee noted the action taken by NJB regarding De-novo registration under CSAPM.

The Committee approved the proposal of the Textile Committee, Mumbai, a statutory body under MoT, GoI for De-novo registration of vendors with a maximum budget of 27.40 lakhs. It was also mentioned that for additional inclusion of vendors under the Scheme based on further proposal received, the budget may enhance proportionately.

Agenda 4: Draft Online Claim Application Format

The draft online claim application has been thoroughly scrutinized by the Committee. The proposal of Sh. Anil Kariwala for incorporating HS Code against the claimed machines into online claim format has also been discussed in length. After due deliberation the Chairman desires that Sh. A. Kariwala may prepare the document in this regard and forwarded to NJB for further circulation amongst the TC members. Further, if required a PPT presentation may be given before the next TC meeting for further deliberation.

Meanwhile, the format was considered as approved by the Chairman for incorporating into the online claim application system.
