## TENDER NOTICE FOR "JUTE FAIR SHIMLA-2022"

Sealed Tenders are invited by the Secretary, National Jute Board (NJB), Ministry of Textiles, Govt. of India from the bonafide interior decorators/exhibitors of repute with good financial standing; having Annual Turnover of over Rs.10.00 lakhs in atleast three years of the last six financial years and having done octonorm based design & construction of anv fairs/exhibitions for Stalls/Booths/Pavilion for Deptts./Organizations/EPCs/Industry Bodies (including NJB) in the past 6 years for the value of over Rs.5.00 lakhs each; for design, decoration and setting up of NJB's stalls in an open area measuring about 4,000 Sq. ft.( ± plus-minus 10%) for an exhibition to be held from 27th May, 2022 to 5th June, 2022 at Indira Gandhi State Sports Complex, Mall Road, Shimla (total 10 days). The space (Open area) will be made available from the evening of 26<sup>th</sup> May, 2022. The job involves fabrication of around 22-25 'stalls with enclosure of more or less 100 Sq.ft each (2 x 2, 2x3, 3x3 as per availabilities of space), for sales arrangement, one stall with enclosure of more or less 100 sq. ft. for NJB Office. The above job should be completed by 23 hrs. on 26th May, 2022. Similarly, the fabrication should be dismantled on conclusion of the exhibition at 24 hrs. on 5<sup>th</sup> June, 2022 night itself.

## JOB SPECIFICATIONS

Each stall will have to be provided with one Mica table, two chairs, two tube lights, 3 spotlights and basket for wastes. All stalls and walking passage are to be provided with wall to wall carpets. The stalls should also be covered from roof side to shelter them from rain. One sofa set, one center table and two small side tables for the Office are to be provided. General Lighting, decoration will be required along with Welcome Banner/Gate (Fascia) of the size 12 x 4 Ft, with NJB Logo in Digital Printout, and other matters flex base material at the Entrance of the Hall, with 2 nos. side panels of size 8 x 1 ½ Ft. (Matter for Fascia will be provided 3 days before the event), for the event. Name Boards with names of the participants of suitable size will have to be provided (one name per stall - names will be provided one day before the event). 20 Flex banners ( 6 x 4 Ft. each) & 2 backdrops (9x12 Ft.) each in Iron frame with stands to be provided.

The Exhibition Hall is to be provided with: 1 No. "Thank you, Please Visit again" board, 2 Nos. "No Smoking Please" boards & 4 Nos. direction/sign boards with stands.



## INAUGURAL ARRANGEMENTS

A red color ribbon & 1 No. Scissors & one decorative tray, 1 inauguration lamp (with cotton and oil for lighting) with candle & match box suitable for inauguration, are to be placed at the entrance of the hall for inauguration.

The whole job is to be executed as a "TURNKEY PACKAGE". Rates quoted should provide for 2 (Two) Security Guards, Cleaning, Sweeping, etc.

Electricity charges & additional lightings (on actual) will be borne by NJB (Necessary approval from concerned State Electricity Board/Agency is to be obtained by Tenderers). The rates should include the total hiring charges for all the above inclusive of To & Fro transportation, erection, maintenance throughout the period of exhibition and dismantling. Income Tax (TDS) will be deducted at the time of making the payment at the applicable rates. PAN and IGST/GST Registration Number, Profession Tax Regn. No., should be mentioned in the tender document.
