Sir,

With reference to the subject cited above, I am to inform you that the permission of the undersigned is hereby accorded in principle for organization of Comprehensive Textile Event in Currency Building from 15<sup>th</sup>-22<sup>nd</sup> December, 2018 subject to the following terms & conditions:


1. The organizer shall ensure that no obstruction is caused to the free movement of visitors within the protected area of the monument.
2. The said event will be organized in consultation with the undersigned or his/her nominated representative.
3. The organizer should take all adequate precautionary measures for safety of the monument.
4. No additions/alterations/damages to the permanent structures are made for the exhibition purpose and the organizer to ensure that no damage is caused to the protected monument.
5. Organizer not to erect any permanent structure within the protected monument as exhibition.
6. Any kind of digging and fire activities shall not be allowed within the protected area.
7. The organiser shall ensure strict adherence to the provisions contained in Rule 8 of Ancient Monument and Archaeological Site and Remains Rules, 1959.
8. The site shall be vacated and left neat & clean soon after the programme is over.
9. The damage, if any caused to the monument or part thereof during the period of the event, shall be responsible by the organiser and the amount thereafter shall be determined by the Director General/Superintending Archaeologist, Archaeological Survey of India, whose decision in the matter shall be final and binding.

10. The instructions should be followed strictly and any violation of the terms and conditions will lead to the withdrawal of the permission.
