

**MINUTES OF THE 12TH MEETING OF THE TECHNICAL COMMITTEE (TC) OF
CAPITAL SUBSIDY SCHEME ON ACQUISITION OF PLANTS & MACHINERY [CSAPM]
-for JDP manufacturers**

Date and Time : 7th March' 2025, 11:30 A.M.

Venue : 8th Floor, Patsan Bhawan, Newtown (through Hybrid Mode)

The meeting was Chaired by the Jute Commissioner. On behalf of NJB, Dr. Mahadeb Datta, Director (TT) welcomed all the attendee members. Thereafter the agendas were taken up for discussion. The list of attendees present physically and virtually is enclosed at **Annexure – I**.

Agenda 1: Confirmation of the Minutes of the 11th Technical Committee under CSAPM held on 20.08.2024

The minutes of the 11th Meeting of the Technical Committee under CSAPM held on 20.08.2024, after being duly approved by the Chairman, were circulated to the members vide NJB's mail dated 17.09.2024.

Since, no further correspondence received in this regard, the minutes have been considered as approved by the Committee.

Agenda 2: Action Taken Report on 11th Technical Committee (TC) meeting directions

- **Regarding revised Price-List:** The Committee noted the actions taken by NJB as per direction of the 11th TC meeting.
- **Regarding the incorporation of Core & Non-core category machines into the online CSAPM system probationally:** The Committee noted the actions taken as per direction of the 11th TC meeting.
- **Regarding the meeting held between Bank & JDP Sector to facilitate credit link issue:** The Committee noted the actions taken.
- **Regarding the matter related to the claim submitted by M/s Alo (NJB-08-ALO-06102023-91) & M/s Ashoka Exports (NJB-08-ASE-29032023-56 & NJB-08-ASE-17102023-92):** After detailed deliberation, the Committee advised that the matter may be taken up with the higher official i.e. Zonal Manager / Head of the Concerned Bank and issue a letter in this regard. Subsequently, NJB officials along with the concerned claimant shall visit the Branch office for obtaining necessary documents as per the Scheme.

Agenda 3: Matter related to De-novo Registration under CSAPM

▪ **Revised recommendation of eligible core vendor for enlistment:**

The status of De-novo process was discussed in details during the meeting. In addition, to the 20 nos. of vendors (foreign & indigenious) enlisted during the previous meeting of the Technical Committee, based on the recommendation given by the Textiles Committee, 3 more vendors have been approved by the Committee as enlisted under the Scheme.

Further, Secretary, NJB expressed his dissatisfaction regarding the time taken for De-novo registration process and requested Textiles Committee to expedite the process so that further action can be done by NJB at the earliest.

Sh. R. Chandran, Dy. Director, Textiles Committee also highlighted the challenges faced related to obtaining of required documents from the applicants who have been applied for De-novo as per the Scheme.

It was also discussed and clarified by NJB that the maximum basic price of machines (model -wise, specification-wise) against which enlistment sought for, is to be assessed, based on the statement of machine cost and catalogue provided by the concerned vendor.

▪ **Revised Price-List:**

Detailed discussion had on the revised price-list forwarded by the Textiles Committee, Mumbai vide mail dated 03.03.2025 and approved by the Committee. Textiles Committee was advised to re-examine the typo-error part for rectification.

The Chairman advised NJB to publish the same in www.jute.com

Agenda 4: Status of online LOI, Claim under CSAPM

The Committee deliberated on the status of the Scheme. The Chairman reiterated that more involvement of the Industry Association/s is required for better disseminate of benefit amongst the Jute Diversified Industry.

Sh. Anil Kariwala, Director, M/s Kariwala Industries Ltd. proposed some possible modifications in the Guidelines towards simplifying the entire process. Secretary, NJB requested Chairman, JPDEPC to hold a brainstorming meeting in consultation with Sh. Anil Kariwala and in presence of other stakeholders of JDP Sectors preferably in Patsan Bhawan where necessary deliberation can be done on such proposals in line of the other

subsidy schemes floated by Govt. of India for MSME sector and execute the take-way while drafting the Operational Guidelines of upcoming subsidy Scheme.

Agenda 5: Any other issues with the permission of the Chair

- **Matter related to the claim submitted by M/s Eco Jute Pvt. Ltd. (NJB-08-ECO-07062023-77):**

The matter was discussed at length and rejected the case.
